

NOVA SCOTIA CONSTRUCTION LABOUR RELATIONS ASSOCIATION LIMITED
APPLICATION FOR MEMBERSHIP AND BARGAINING AUTHORIZATION

CAPE BRETON ISLAND, NOVA SCOTIA – ACCREDITATION ORDER L.R.B. NO. 428C

The undersigned having familiarized itself with provisions of the Memorandum of Association & Articles of Association, hereby applies for membership in the Nova Scotia Construction Labour Relations Association Limited (hereinafter referred to as the “CLRA”), with all rights, privileges and obligations granted or imposed by the Memorandum of Association and Articles of Association.

The undersigned agrees to pay the CLRA dues, fees and assessments levied in accordance with the provisions of the Memorandum of Association & Articles of Association of the CLRA, initially to be in the amount of a NIL Entrance Fee, and CLRA Dues to be in the amount equal to 13¢ per man hour worked in the Province of Nova Scotia by unionized employees of the undersigned, employed in any of the trades in the construction industry as set out in the Memorandum of Association & Articles of Association. The undersigned agrees to pay to the CLRA dues for each calendar month not later than the 15th day of the following month, and agrees to submit to an inspection and audit of its payroll for the purpose of reconciliation of such dues, fees and assessments by an independent professional auditor. All members shall pay an absolute minimum dues of \$500.00 per annum payable by the first day of June of each and every year.

CLRA dues are paid for “on-site construction” operations in the accredited bargaining area. The Construction Industry Panel in Accreditation Order No. L.R.B. 428C April 5, 1977, ruled that the accreditation for the Industrial & Commercial Sector included:

“ all employers who in the 12 months preceding the date of Application were engaged in Nova Scotia in **any aspect** of the construction industry **other than** pipe line construction bridge building, road building, the construction of sewers, tunnels and water mains and house building”.

Subject to acceptance of this application for membership, and in order to meet the requirements of the Memorandum of Association & Articles of Association, the undersigned hereby assigns to the CLRA, during its continuation of membership, its rights to bargain collectively with only those trade unions identified on Schedule “A”, attached entitled “Trade Group Participation” by the undersigned applicant and exclusively within the accredited sector of the construction industry in Nova Scotia and hereby authorizes the CLRA and hereby appoints the CLRA as its exclusive limited agent during the continuation of membership of the undersigned in the CLRA for those trade unions identified in Schedule “A” only.

- (1) To bargain collectively on the undersigned’s behalf and in accordance with the provisions of the Memorandum of Association & Articles of Association, to enter into a collective agreement or collective agreements or other undertaking or contract, with a trade union or trade unions with reference to the employment of labour on such terms as the Association consider proper, and to amend, vary, modify, cancel or terminate the same, only within the accreditation area(s) and trade(s) identified by the undersigned in Schedule “A”, Trade Group Participation” attached;
- (2) The undersigned agrees that it will not perform on its own behalf, or authorize or appoint any other person, firm or corporation to perform any of the aforesaid matters or things.

If this application is accepted, the undersigned agrees to observe, perform and be bound by the applicable provisions of the Memorandum of Association & Articles of Association of the CLRA as a contract with the CLRA, and with each of the members thereof, to the same extent as if they had been signed, sealed and delivered by the undersigned, the CLRA and by each of the members thereof.

SCHEDULE “A”

TRADE GROUP PARTICIPATION & COLLECTIVE BARGAINING AUTHORIZATION BY APPLICANT EMPLOYER

The applicant must fulfill two conditions of this application. Firstly, the applicant must be an employer of unionized employees. Secondly, the applicant employer must be certified by a building trade union or have given voluntary recognition to a building trade union.

Any applicant employer meeting the two conditions set forth above shall make an “X” beside each trade from which that employer employs unionized employees and for which the CLRA will act in collective bargaining on behalf of the applicant as a sole operator/owner, or firm or corporation which is applying for membership.

The applicant specifically does not recognize any other trade unions other than those marked with an “X” and the applicant’s membership in the CLRA is thereby limited in this manner.
