Attached is Amendment #2 to the 2021-2026 Mechanical 244 Collective Agreement, effective January 1, 2025, now named the Mechanical 56 Collective Agreement for the former Local 244 geographic region.

This amendment stems from the winding-up of UA Local 244 into UA Local 56. The primary reason for this amendment was to ensure that remittances were being sent to the proper addressees and administrators; there should be no practical change to the agreement. Until the expiry of this agreement, all terms, conditions and rates from the attached former UA Local 244 agreement should continue to apply to UA work performed in the former geographic region of UA Local 244, as follows: "From Black Rock, Colchester County proceeding to the junction of Colchester, Pictou, Halifax and Guysborough Counties as a straight line, continuing along the straight line separating Guysborough County and Halifax County. All the area east of this line on the Mainland of Nova Scotia."
