Negotiated changes to a collective agreement are indicated with an underline and companies are encouraged to read through the agreement to be aware of all changes, including the following:

### **Craft Schedule**

- Premium for Working Foreperson.
- For monetary increases and updated amounts for Health & Welfare, Pension and Training, please refer to the wage tables within the agreement.
- For May 1, 2029, the increase is subject to the Cost of Living Memorandum of Agreement attached to the end of the collective agreement.

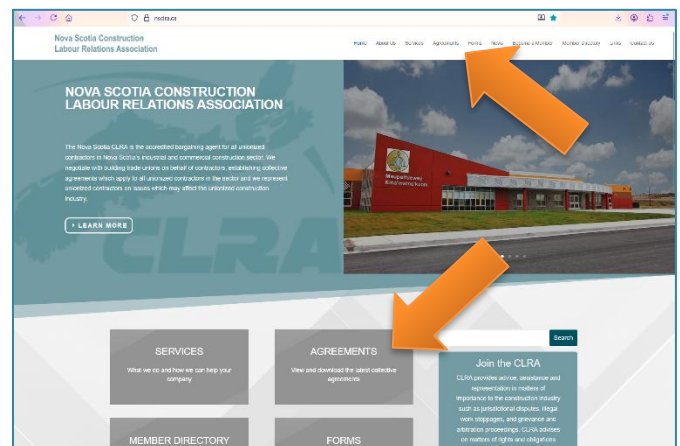
